CARL BECKER

Carl Becker (22 Dec 1853 - 26 Aug 1888), ninth child of Georg Caspar Becker (#25 on the Becker lineage chart) and Katharina Bunding (#229/6 on the Bunding lineage chart), was born in Nieder-Gemunden, Germany. he arrived in the United States in 1871. On 17 Mar 1881 he applied for citizenship at the St. Charles Co. courthouse and after fulfilling his five year residency requirement he became an American citizen on 16 Oct 1886.

On 19 May 1881 he was married to Catherine Caroline Wolter (20 Dec 1861 - 26 Feb 1939) in St. Charles, Missouri, by the Rev. J. H. P. Graebner of the Immanuel Lutheran Church. All of their children were baptized at this church.

Carl Becker lived on North Benton Street in St. Charles, Missouri. He was a butcher and had a meat market. Since there are no living descendants not very much is known about his life. After his death his widow was married to Charles Roedenbeck.

Carl Becker was the godfather of August Carl Becker, the son of his cousin, John Casper Becker, and the father of this book's writers.

Carl and Caroline are buried in the Immanuel Lutheran Cemetery. They had four children (three of whom died in infancy and are buried in the same cemetery):

She was baptized at the Immanuel Lutheran Church and on 8 Jun 1904 was married there to Francis Otto Feldmann (20 May 1877 - 9 May 1943), son of Francis Feldmann and Katherine Adelhaid Schone. Julie is buried in the Immanuel Lutheran Cemetery. They had one child:

Francis Waldemar Feldmann (1 May 1912 - 8 Jun 1951), only child of Francis Otto Feldmann and Julie Caroline Wilhelmine Becker, was born in St. Charles, Missouri. He married Sophia Mueller. He is buried in Immanuel Lutheran Cemetery. They had no children and so this is the end of this line.
